## *1. Crime and Patrol Summary*

*See attachments. The department responded to 1,305 requests for service during the month of July. Community Service responded to 155 requests for service.*

*I know I am sounding like a broken record, but the trend of thefts from vehicles and thefts of vehicles for "joy riding" continued this month. Many of the vehicles were not locked and some had keys. Items reported stolen ranged from small amounts of change to firearms. Bicycles were also a target to be stolen. Most of these stolen bicycles were not secured in any fashion. We highly encourage the public to secure their vehicles and bicycles.*

*This month the School Resource Officers attended training gearing up for the upcoming school year. Officers Fritz and Businger will be ready to meet the school district staff and update them on new ways to make the school safer.*

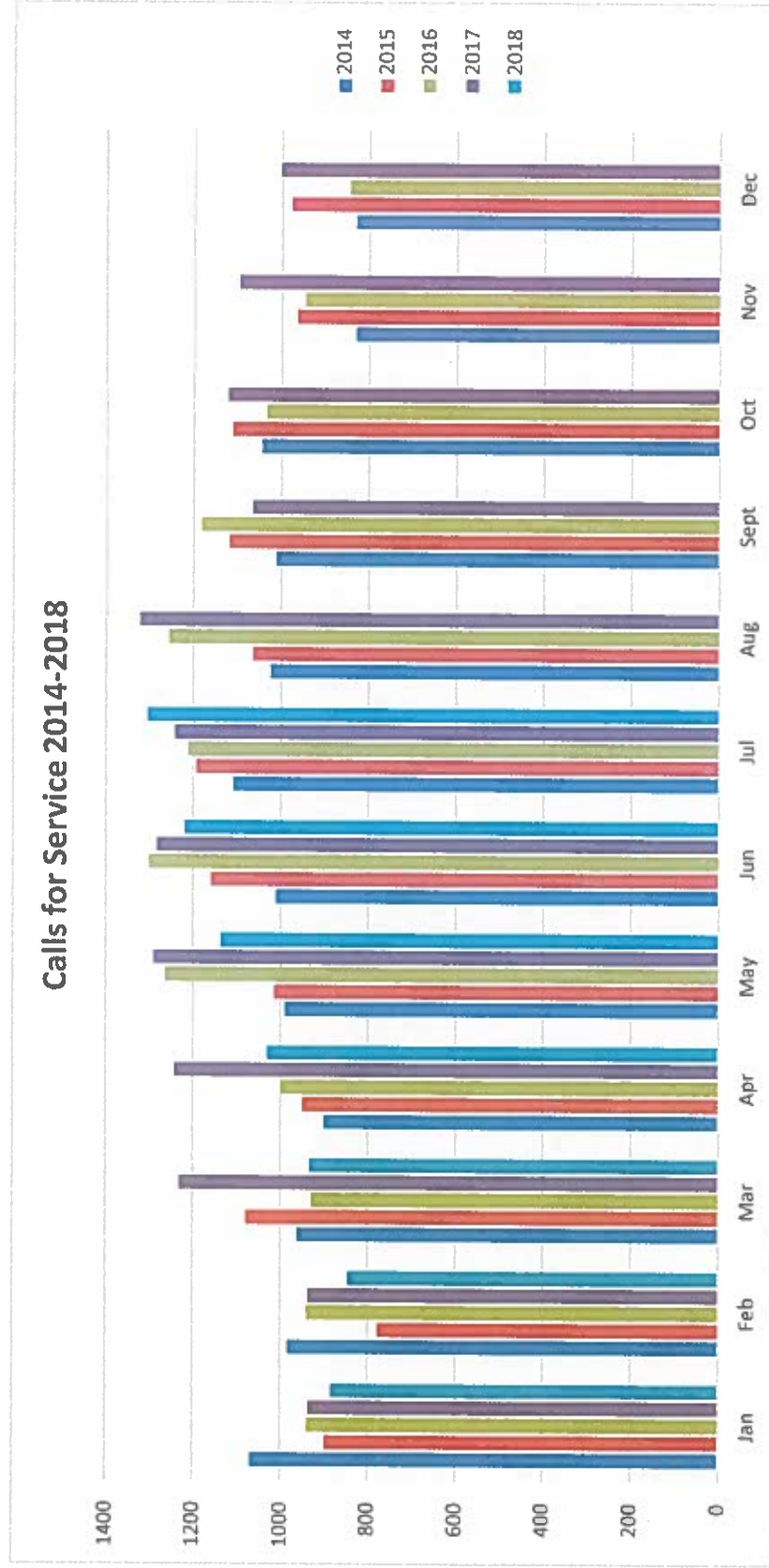
